More Super Bazars in Delhi

(b) if so, the number of such bazars proposed to be opened and the amount to be invested in each of them; and

I HE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI ANNASAHEB P. SHINDE): (a) Branches of the Super Bazar are to be opened by the Co-operative Store Ltd. (Super Bazar), New Delhi, which is an autonomous institution, and not by the Government.

(b) The Super Bazar has plans to open 20 branches, in addition to its earlier 9 branches. The investment to be made in each branch will vary, as it will depend on its location. sales potential, size of the selling area, rental, staff strength, etc.

(c) The Super Bazar proposes to open new branches in different localities of Delhi and New Delhi, subject to availability of suitable accommodation at a reasonable rental. Out of the proposed 20 new branches, three have already started functioning, at the Delhi University Campus, Jama Masjid
