Faculties in Universities and colleges throughout the country; and

(b) if so, what are the details thereof?

THE MINISTER OF EDUCATION. AND CULTURE WELFARE SOCIAL (PROF. S. NURUL HASAN): (a) and (b) The Committee on governance of Universities and Colleges set up by the University Grants Commission in its report on "Teachers" has, in the context of revised scales of pay for university and college teachers, inter-alia, recommended that a lecturer/reader who completes six years of service and claims that he has done outfulfills the minimum standing work and qualifications laids down by the University for reader/professor as the case may be, may offer himself for assessment by a duly constituted Selection Committee of the University. If he is found to have done outstanding work he should be given the next scale and rank which should be personal to him. Similarly a lecturer/reader who has reached the maximum of the scale may offer himself for assessment by a duly constituted Selection Committee next scale. The for promotion to the University Grants Commission has accepted in principle the concept of 'Presonal Promotions' recommended by the Committee with certain modifications, details of which are being worked out by the Commission.
