THE MINISTER OF SHIPPING AND TRANSPORT (SHRI KAMLAPATI TRI-PATHI): (a) and (b) A statement is laid on the Table of the Sabha.

Statement

Presumably the Members want to have information about funds 'earmarked' for

the construction of, and repairs National Highways in Madhya Pradesh and Rajasthan and actual disbursements against those funds. There is, however, no such State-wise earmarking of funds in respect of National Highways over a Plan period. Funds are allotted yearly according to budgetary resources and total requirements and utilised by States on the basis of work-wise allotment made to them. The table below indicates the funds allotted to Madhya Pradesh and Rajasthan for construction and repairs of National Highways and actual expenditure incurred by them against those allotments:

- (a) whether it is a fact that a person without a diploma or degree in any foreign language is working as an Assistant Professor of Foreign Language at the Indian Institute of Science, Bangalore; and
- (b) if so, what are the reasons therefor?

THE MINISTER OF EDUCATION. SOCIAL WELFARE AND CULTURE (PROF. S. NURUL HASAN): (a) and (b) In October, 1963 when recruitment to the post of an Assistant Professor in foreign languages at the Indian Institute Science, Bangalore was advertised the advertisement made did not stipulate any condition that the candidate must possess a diploma or degree in any foreign languages. One of the essential qualifications prescribed was a Post-graduate degree in linguistics or languages from a recognised university and proficiency in atleast two of the following languages: French, German, Russian in addition to English. The job specification was principally to assist students and members of the staff to attain such knowledge in German, French, etc. as will enable them to read technical books and journals and other advanced scientific literature. The candidate appointed to the post with effect from 2nd of July, 1964 fulfilled the essential qualifications advertised as he has a Ph.D. in linguistics. He has teaching experience in French and experience in translation work in French. German. Italian. Spanish and Russian. He has also published translations/reviews of books in Russian and German. He was selected by a duly constituted Selection Committee of the Council of Indian Institute of Science, Bangalore.
