Expenditure on the Establishment of a Central University in Hyderabad

(d) whether the Central Government are proposing to issue instructions to the State Government in this regard?

THE MINISTER OF EDUCATION, SOCIAL WELFARE AND CULTURE (PROF. S. NURUL HASAN): (a) The Working Group, set up to work out the details of the proposed University of Hyderabad. had, at the time of submitting its report in March, 1974 estimated a recurring expenditure of Rs. 3.04 crores for a period of five years and a nonrecurring expenditure of Rs. 11.60 crores for a period of ten years on the establishment of the University.

(b) The University is being established in pursuance of the Six-point Formula on Andhra Pradesh which has been accepted by the Government. The question of diverting funds for the University to set up primary schools is, therefore, not relevant.

(c) and (d) The policy for opening of universities and institutions of higher expansion of facilities learning and for for primary education has been laid down in the draft Fifth Five Year Plan. Separate allocation of funds has also been made in the draft Plan for these sectors. It may further be stated that under Section 12-A of the University Grants Commission (Amendment) Act, 1972. "no grant shall be given by the Central Government, the Commission, or any other organisation the Central receiving any funds from Government, to a University which is established after the commencement of the University Grants Commission (Amendment) Act, 1972, unless the Commission has, after satisfying itself as to such matters as may be prescribed, declared University to be fit for receiving such such grant."

Friends Central Government Employees Cooperative House Building Society

1166. SHRI B. V. ABDULLA KOYA: Will the Minister of WORKS AND HOUSING be pleased to state:

(a) the period fixed by the Delhi Development Authority within which a cooperative house building society is required to develop land allotted to it and file the layout plan; (b) the date on which first layout plan was filed by the Friends Central Government Employees Cooperative House Building Society Ltd., New Delhi, with D.D.A. and the number of plots given in the layout plan;

(c) whether the D.D.A. had asked the society to the another plan with more plots;

(d) whether the plan has since been sanctioned and released; and

(e) if so, when the plan has been released and of how many plots?

THE MINISTER OF STATE IN THE MINISTRY OF WORKS AND HOUS-ING (SHRI OM MEHTA): (a) The society is required to develop the land, in accordance with the approved plan, within three years from the date of execution of agreement between the lessor (Lt. Governor, Delhi) and the lessee (the society). No period is fixed for submission of the layout plan.

(b) The first layout plan was submitted on the 19th February, 1972 and was for 240 plots. Since this plan was not in accordance with the Master Plan, the Society submitted a fresh layout plan for 238 plots on the 29th March, 1973.

(c) to (e) As required by the Delhi Administration, the D.D.A. asked the society to submit another layout plan for 240 plots which it did on 29th January, 1974. This revised layout plan, which was' in accordance with the Master Plan standards, has since been approved, but not yet released as some certificates from the Society are awaited.
