- (c) Although there has been substantial increase in the marketing of domestic gas in each year compared with the previous year, the marginal shortfall in actual saic against targets was due to the inadequate availability of cylinders and seasonal shortfall in upliftment due to operational reasons and breach of rail/road transport.
- (d) Manufacture of LPG cylinders re quires special quality steel, indigenous production of which is limited. Arrange ments have now been made to meet the shortfall through imports. IOC has already imported 5000 tonnes of L.P.G. is Steel during 1973-74. Additional import of 5000 tonnes planned for the current year also. THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND CHEMICALS (SHRI SHAH NAWAZ KHAN): (a) to (c) A representation has been received from the Indian Soap & Toiletries Makers' Association for increases in the prices of soaps manufactured by the organised sector on account of increased cost on oils and fats. This is under examination by Government.
