THE MINISTER OF RAILWAYS (SHRI L. N. MISHRA) : (a) A proposal for 30 railway lines in the Maharashtra State had been received from the Buildings and Communications Department of the Government of Maharashtra. Surveys are in progress in case of three projects while the construction is being carried on in case of two projects.

(b) In view of the limited funds for the construction of new railway lines, it has not been found possible to take up other projects at this stage.

Will the Minister of PETROLEUM AND CHEMICALS be pleased to state :

(a) the quantity of liquified petroleum gas (Indane) sold by the Indian Oil Corporation during 1971-72, 1972-73 and 1973-74 ;

(b) what was the production target fixed and what has been the shortfall during these years;

(c) what are the reasons for the shortfall ; and

(d) what steps Government propose to take to meet the production target in future ?

THE MINISTER OF PETROLEUM AND CHEMICALS (SHRI D. K. BOROOAH) :

(a) and (b) Production of liquified petroleum gas (LPG) is limited by its sales as such. The balance quantity is utilised in the refinery itself along with other gases as fuel. The quantity of L.P.G. (Indane) sold by IOC during 1971-72, 1972-73 and 1973-74, targets fixed for sale and the shortfall during these years is given below :
