switch-board positions, the time to answer on these services, has been reduced and more prompt service is being provided.

- (xiii) The various procedures for attending to faults and complaints have been streamlined. After the adoption of the procedure, complaints and faults are being attended to more expeditiously. The duration of faults is smaller and the number of carried over faults has been reduced
- (xiv) Centralised service observation of the calls passing through the Calcutta Telephone network has shown an improvement by 10% from the position in March.
- (xv) Inspection of the installation at subscribers premises and private branch exchanges is being carried out on the basis of a special schedule.

(xvi) Power shedding continues in different areas of Calcutta. To meet this situation, direct power feeder cable has been laid for the '47' exchange. The work for laying direct power feeder cables to the '24' and the '35' Exchanges is in progress. '22' and '23' and '33' and '34' exchanges already have direct power feeder cables. These Exchanges will not be subjected to power shedding problems. Examination has shown that it is not feasible to provide direct feeders for the remaining exchanges. Except in '58' and '66' exchanges, engine alternators have been provided to take over the exchange load in the remaining exchanges. Action is being taken to provide engine alternators in these two exchanges also. For two other exchanges, '44' and '41/46', larger capacity alternators are being provided.

(xvii) After discussion with the West Bengal State authorities, special liaison has been established with the local law and order authorities to minimise thefts of under-ground cables. It is expected that soon the interruptions to the service due to thefts of cables would be minimised.

(xviii) Close coordination has been established with the various agencies engaged in road digging operations. The damage to underground cables by road digging work is being gradually reduced.

(xix) The management set up of the Calcutta Telephones has been strengthened

and the maintenance work is being organised on an Area basis.

## Criticism by the IAS Officers' Association of the Speech of a Member of Parliament

Will the PRIME MINISTER be pleased to state:

- (a) whether it is a fact that in August, 1973, the I.A.S. Officers' Association of Orissa passed a resolution criticising the speech of a Member of Parliament on the Floor of the Rajya Sabha for his critical remarks against the Chief Secretary to the Government of Orissa:
- (b) whether the Central Government have made any enquiry in the matter: and
- (c) if so, what are the details thereof; and what action Government have taken thereon?

THE MINISTER OF STATE IN THE **DEPARTMENT** OF **PERSONNEL** (SHRI RAM **NIWAS** MIRDHA): to (c) The Government of Orissa whom the facts were ascertained has informed us that the President of the IAS Officers' Association has stated that Member of the Rajya Sabha has been criticised at any meeting of the Association. At a meeting of the Executive Committee of the Association, held on 11-8-1973, a Resolution was passed expressing its distress over some derogatory remarks made on the floor of the House against a member of the Service and felt that criticism of individual officers who were in no position to defend themselves was a sad development which should be brought to the notice of the authorities and that a deputation should wait on the Governor to request him to take the matter up with the Central Government. As the matter pertained to the State Government, a letter received in this regard was forwarded to the Government of Orissa for such action as may be necessary.
