THE DEPUTY MINISTER IN THE MINISTRY OF INDUSTRIAL DEVE-LOPMENT (SHRI Z. R. ANSARI): (a) A statement is attached. [See Appendix LXXXIX, Annexure No. 62]

(b) There is no formal system of allotment of electricity to the Cement Industry- Till August, 1973. there was also no system of allocation of coal to the industry. The Standing Linkage Committee allocating coal to the Cement Industry from September, 1973 onwards and for the period ending December. 1973, the allocation was 18.10 lakh tonnes.

Since January, 1974, the requirements of furnace oil to the cement industry have been restricted to 90°, of their 1973 offtakes. Balance 10% was to be met by adopting economy measures in the consumption of fuel. Any deviation from this principle is to be considered and authorised by the Standing Committee on furnace oil.

The consumption of coal, furnace oil and electricity during the last three years by the Cement Industry has been estimated under: -
