

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM AND CIVIL AVIATION (DR. SMT. SARAJINI MAHISHI): (a) It is not proposed to construct any new 5-star hotels in the public sector during the Fifth Plan Period. The India Tourism Development Corporation will concentrate its efforts on expanding the infrastructure for middle income tourists.

(b) At present there are 3 public sector hotels which offer services and amenities of the 5-star de-luxe or 5 star category. The profit earned by these hotels during the year 1972-73 was Rs. 39.48 lakhs.

#### **Value of Gold, Silver and Precious Gems in the Country**

(a) whether Government have recently made any assessment of the total quantity and value of gold, silver and precious gems in private hands in the country; and

(b) whether Government contemplate some measures to utilise this unproductive wealth for national development by collecting all such gold, silver and precious gems on pledge basis?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI K. R. GANESH), (a) It is not possible to make any reliable estimate of the total quantity and value of gold, silver and precious gems in private hands in this country.

(b) In the present inflationary environment it is not a practical proposition to mobilise private holdings of gold by any system of pledge. However, Government has recently decided to legalise exports of silver. To that extent the export proceeds from silver will be available for meeting the requirements of foreign exchange.
