

**Lock-out in the Indian Standards Institution**

Will the Minister of INDUSTRIAL DEVELOPMENT AND SCIENCE AND TECHNOLOGY be pleased to state:

(a) whether a lock out has recently been declared in the Indian Standards Institution; and

(b) if so, what are the reasons there for?

THE MINISTER OF INDUSTRIAL DEVELOPMENT AND SCIENCE AND TECHNOLOGY AND AGRICULTURE (SHRI C. SUBRAMANIAN!): (a) The terms "lock out" applies to industry, and the I.S.I. being only an Institution the question of lock out in the Institution does not arise. However, the functioning of the I.S.I.'s Headquarters Office remained suspended from 17th May to 9th June, 1974.

(b) The Institution's work had been paralysed by cessation of work, agitation and noisy demonstration by a large section of Grades II, III & IV of ISI Employees from 22nd March to 16th May, 1974 who were agitating for enhancement of House Rent Allowance from 20 to 25 percent on the revised pay scales. A situation had arisen in which keeping the Institution open was fraught with risk and danger to its property and to loyal employees.

**Reorganisation of Directorate General of Technical Development**

(a) whether the Directorate General of Technical Development has been reorganised; and

(b) if so, what are the details of the new set up?

THE MINISTER OF INDUSTRIAL DEVELOPMENT AND SCIENCE AND TECHNOLOGY AND AGRICULTURE (SHRI C. SUBRAMANIAM): (a) Yes. Sir.

(b) The salient features of the re-organisation lay emphasis on technical development functions rather than on regulatory functions, in which it was more prominent in the past. The major plank of strategy is increased communications and rapport with industries, associations of industry research and developments Organisations, Chambers of Commerce and Industry etc. on matters relating to increased export generation, import substitution, conservation of scarce imported materials, technological improvements etc.

2. Divisions/Directorates concerned with energy conservation, technology development, policy and plans, material conservation and information system have been formed.

and (b) In the light of the statements made by Sheikh Mohamad Abdullah to the effect that he regarded himself committed to the act of accession of the State of Jammu and Kashmir to India, Government of India, after consulting the State Government, agreed that Shri G. Parthasarathy and Sheikh Abdullah's nominee, Shri Afzal Beg, could meet with a view to exchanging ideas. In continuation of the discussions held between the two, Shri Swaran Singh, Minister of External Affairs, met Sheikh Abdullah and had talks with him in June, 1974. The discussions are continuing.

THE DEPUTY MINISTER IN THE MINISTRY OF INDUSTRIAL DEVELOPMENT (SHRI Z. R. ANSARI): (a) An amount of Rs. 1,914.19 lakhs was spent on the Ambar Charkha Project (including New Model Charkha Programmes) upto 31st March, 1973.

(b) 1,58,085 Ambar Charkhas (including New Model Charkhas) are in use in the country.

#### Home for aged and infirm freedom fighters

THE DEPUTY MINISTER IN THE MINISTRY OF HOME AFFAIRS (SHRI F. H. MOHSIN): (a) It has already been decided to set up a temporary Home in Delhi for about 25 aged and infirm freedom fighters who Travelio 6"he to look after.

(b) and (c) The procedure for admission to the temporary Home will be finalised after suitable accommodation has been secured and other administrative arrangements have been completed.
