report for the establishment of a pellati-sation plant based on iron ore mines; at Bailadila in Madhya Pradesh; and

(b) if so, what are the details in this regard and by when it is likely to commence work?

THE DEPUTY MINISTER IN THE MINISTRY OF STEEL AND MINES (SHRI SUKHDEV PRASAD): fa) Yes. Sir.

(b) The report, which was submitted in January. 1972, envisaged the establishment of a pellet plant with an annual capacity of 2 million tonnes at Bailadila. The report put forward four alternative schemes depending upon the nature of the raw material to be utilised. The total capital requirement including plant cost, township, preliminary expenses, training expenses, interest on longterm loan during construction and working capital ranged from Rs. 32.65 crores to Rs. 34.55 crores. Since the scheme has not been included in the 5th Five Year Plan, it is not possible to say if and when the scheme will be implemented.

## **Industrail Relations Bill**

383. SHRI S. W. DHABE: Will the Minister of LABOUR be pleased to state:

- (a) whether Government have accepted the recommendations of the National Labour Commission with regard to Industrial Relations Commission; and
- (b) if so, since when the comprehensive Industrial Relations Bill has been under Government's consideration and by when it is likely to be introduced in Parliament?

THE DEPUTY MINISTER IN THE MINISTRY OF LABOUR (SHRI BAL-GOVIND VERMA): (a) Government have discussed these recommendations with the various interests concerned. Final decisions will be taken as early as possible.

fb) A comprehensive Industrial Relations Bill has been under consideration for the last two years or so and efforts are being made to introduce the Bill in the Parliament early as possible.

THE DEPUTY MINISTER IN THE MINISTRY OF LABOUR (SHRI BAL-GOVIND VERMA): (a) A statement showing the index numbers of money earnings and real earnings of factory workers covered under the Payment of Wages Act, 1936 and drawing less than Rs. 400 p.m. is enclosed.

(b) According to available (Provisional) data collected under the collection of Statistics Act (Annual Survey of Industries) wages constituted 38.3 per cent of value added by Manufacture in 1968 and 34.7 per cent in 1969.
