- 1332. SHRI L. MAHAPATRO: Will the Minister of RAILWAYS be pleased to state:
- (a) the number of substitute teachers appointed in Chakradharpur division of South Eastern Railway from 1968 to date and the approximate length of their service.
- (b) what are the rules regarding the appointment and termination of services of such teachers:
- (c) whether the said rules have been violated and if so on how many occasions and the reasons therefor; and
- (d) whether such teachers who have completed three years and above in the grade are likely to be absorbed as regular teachers?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI MOHD. SHAFI QURESHI):

- (a) 72. The length of their service varies from two months to six years.
- (b) and (c) A statement is attached. [See Appendix LXXXIX, Annexure No. 76.]
- (d) Yes. It is proposed to consider such substitute teachers for regular appointment through special selection, subject to their possessing the requisite qualifications and their being within the prescribed age limits.

- (c) Surprise checks are carried out against ticketless travel and whenever such cases are detected, the matter is brought to the notice of the concerned State Government authorities for taking action against the delinquent Police Personnel.
