The balance quantity will have to be lifted in the next month.]

expenditure on the construction of Temporary Hospitalization wards, purchase of equipments, vehicles, microscopes, purchase of drugs for leprosy patients and the operational cost of the Scheme.

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI ANNASAHEB P. SHINDE): (a) and (b) It is primarily the responsibility of the State Governments to assess the requirements of certiied seeds and ensure the supply of seeds. The Government of India conduct a review of the arrangements being made by the State Governments and supplement the efforts of State Governments through Organisations like the National Seeds Corporation, State Farms Corporation etc. The National Seeds Corporation expects to supply during 1974-75 26,534 quintals of maize, 13,966 quint;"s of sorghum, 12,165 quintals of bajra, 89,605 quintals of paddy and 137330 quintals of wheat seeds.

Demand of foundation seeds

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI ANNASAHEB P. SHINDE): (a) and (b) It is the primary responsibility of the State Governments to make assessments of the requirement of quality seeds and the seed production programmes to be organised for meeting the seed requirements and what quantities of foundation seeds of different crops would be required for the purpose. The foundation seed production is undertaken mainly by the National Seeds Corporation, a Government of India undertaking, as also agricultural universities and some State Departments of Agriculture. In so far as the N.S.C. is concerned, indents lor foundation seeds of varieties of all-India importance are required to be placed one year ahead of the sowing season. As far as 1974-75 is concerned, the Corporation has met the requirements of foundation seeds of all the seed producers who had placed orders one year ahead. In respect of seed producers who did not place indents in time, in view of inadequate availability, the full requirements could not be met. The quantities of foundation seeds allotted as against indent are given below:
