- 421. SHRI N. Н KUMBHARE: Will the Minister of LAW, JUSTICE I AND COMPANY **AFFAIRS** pleased to state:
- (a) What is the total accumulation of money with liquidator of the Globe Motors Private Limited;
- (b) whether any progress has been made to settle the issue of payment among the creditors; and
- (c) if so, the nature of decision taken and when further instalments will be given to the creditors?

THE DEPUTY MINISTER IN THE MINISTRY OF LAW, JUSTICE AND COMPANY AFFAIRS (SHRI BEDA-BRATA BARUA): (a) The company is not under liquidation but is managed by a Committee of Management appointed under a scheme of arrangement sanctioned by the Delhi High Court which became effective on 22nd February, 1970. The Government has no information about the total accumulation of money with the said Committee.

(b) and (c) It is reported that under the scheme a total sum of Rs. 1.72.94.197/was claimed by the creditors. Out of this amount the company had admitted Rs. 1,23,93,789/- leaving aside the payment of Rs. 38,70,348/- on account of reduction by appeals or settlement. A sum of Rs. 10,30,060/-is under dispute and payments not covered under the scheme amount to Rs. 95,07,207/-.

Up to 30th June, 1974 payment ol Rs. 84,46,612/- has been made in respect of claims admitted under thi

scheme and Rs. 39,77,064/- in respect of the claims not covered by the scheme. The payments were to be made in six instalments, the last instalment being due by 22nd March, 1974. The company has filed an application to the Delhi High Court for extension of time for this payment upto 22nd March, 1975. The matter is now pending before the Court.
