THE MINISTER OF PETROLEUM AND CHEMICALS (SHRI D. K BOROOAH): (a) About 19 per cent cf the explored oil and gas wells in the country are lying idle.

(b) The provision of well head and production installations. workover operations, laying of flowlines, pipelines etc. are among the steps taken for the exploration of the deposits. In Galeki field of ONGC a well-head installation has recently been installed and it is expected to put this field on trial production in the near future.

SHAFI QURESHE): (a) to (c) Due to situation arising out of the recent Railway strike, a total of 14 pairs of passenger trains still remain suspended on South Central Railway. Restoration of these trains is being considered in a phased manner and some of them will be re-introduced shortly.

North Brook Jute Company Ltd.

- (a) whether it is a fact that North Brook Jute Company Ltd., Calcutta, a unit of M/s. Heilgen Pvt. Ltd., has recently changed hands;
 - (b) if so, what are the details of the deal;
- (c) what is the name of person who now holds the controlling interest in the North Brook Jute Company; and
- (d) what action has been taken by Government in this case for violation of Section 250 of the Companies Act?

THE MINISTER OF LAW, JUSTICE AND COMPANY AFFAIRS (SHRI H. R. GOKHALE): (a) Yes, Sir.

- (b) and (c) The equity capital of North Brook Jute Company Ltd., Calcutta consists of 1,67,988 shares of Rs. 10 each fully paid up. During the period 1-8-73 to 7-11-73, a large number of shares changed hands. The details of the transfers of shares (IOO and above) are given in the enclosed statement. As a result of these transfers, Shri Ram Gopal Ganeriwalla, his bro-thers's son and 2 companies under the control of Ganeriwalla family acquired 98,299 shares, which represent 58% of the voting power. The acquisitions are in the following names :-
- 1. Bhubandhar Tea Co. Ltd. 17,000
- 2. Ram Gopal Ganeriwalla Pvt. Ltd. 79,299
- Sri Ram Gopal Ganeriwalla 1,000
- 4. Sri Sures's Kumar Ganeri-1,000 walla

(d) Section 250 of the Companies Act enables the Central Government to impose restrictions upon shares and debentures and to prohibit the transfer of shares in certain circumstances. No such restrictions had been imposed in this case. The question of violation of Section 250. of the Companies Act, does not, therefore, arise.
