THE DEPUTY MINISTER IN THE MINISTRY OF INFORMATION AND

BROADCASTING (SHRI DHARAM BIR SINHA): (a) Advertisement tariff is fixed by the newspapers themselves on the basis of their circulation; area of coverage, nature of readership etc. and not by Government. The Directorate of Advertising and Visual Publicity, however, make use of only those newspapers and periodicals whose found economical from the point of view of Government's publicity requirements.

(a) According to the information turnished by the respective State Governments, the contribution made by the Planning Boards of West Bengal, Maharashtra, Gujarat and States of North Eastern Region in formulating the Draft Fifth Five Year Plans is indicated below:

West Bengal .- The State Planning Board formed Task Forces for different sectors and with the help of such Task Forces and after making elaborate exercises on identifying Pian objectives and indicating the methodology for the preparation of the sectoral plans of the Fifth Five Year Plan, a broad based policy statement covering all the sectors of the economy was prepared.
