This programme has generated employment | women of high intellectual ability to for about 1 lakh persons plus 142 lakh mandays.

- (10) In 1974-75 the Planning Commission has made an allocation of Rs. 40 crores for employment promotion programmes with thrust on self-employment.
- (11) Financial assistance is rendered by nationalised Banks to enterprising uncmployed persons.
- (12) Scientists, engineers and technologists are encouraged to set up their own enterprises. The Public Sector Banks provide the total capital needed for such ventures.
- (13) Industrial-Co-operatives formed by scientists, engineers, technologists, etc. with specific projects in view would be entitled to a Government contribution to the equity capital to the extent of three times the capital subscribed to by the pareners. In addition. State Governments would also provide facilities like Infra-structure, Rent subsidy in deserving cases; incentives like exemption for a period from Sales-tax, Octroi, electricity duty, etc.
- (14) Incentives are being offered to employers in the private and co-operative sectors to employ sciencists, engineers, etc. Government would provide incentives to the extent of 50 per cent of the salary subject to a ceiling e.g. Rs. 400 (salary) for engineering degree holders, Rs. 250 (salary) for Post-graduates in Science-for a period of one year to employers who offer jobs to scientists, engineers, e.c.
- (15) The U.G.C. has also taken a number of measures to improve facilities, scales and working conditions, to attract a reasonable proportion of our men and

the teaching profession.
