(c) Following the recommendation made by the Steering Group for drawing up proposals for the Third Five Year Plan, feasibility studies were prepared by M/S M.N. Dastur & Co. for locating a steel plant in the Goa-Hospet region and by Hindustan Steel Ltd. for locating a steel plant in Bailadilla Vishakhapatnam region. The reports were later examined by an independent Technical Committee of Experts and by an Anglo-American Consortium. The Central Engineering & Design Bureau, in 1970, updated these earlier studies, as a result of which Government took a decision in April. 1970 to locate three new steel plants in Visakhapatnam (Andhra Pradesh), Hospet (since renamed as Vijayanagar) in Karnataka, and at Salem in Tamil Nadu.

Provision exists in the draft Fifth Five Plan for taking up detailed techno-economic feasibility studies for new steel capacity. However, due to constraints on resources, such studies can be made use of for the purpose of steel development, only in the Sixth and succeeding Plan periods.
