THE MINISTER OF FINANCE (SHRI Y. B. CHAVAN): (a) Some changes in the system of financial administration are contemplated so as to match the authority for taking decisions with the responsibility for producing results.

(b) These changes will keep in view the need for enhanced delegation of financial powers to administiative ministries and their executive agencies, as found necessary and desirable. These delegations are at present under consideration.

Apart from the measures under the Customs Act, 1962 and the recent strengthening of the Preventive Organisation, various other steps have been taken to combat smuggling on Indo-Bangladesh border. Extensive preventive patrols are undertaken by the preventive units individually and also jointly with the Border Security Force and the Police Parties. Periodical meetings are also being held between the authorities on the Indian side and the Bangladesh side for prevention of smuggling.

- (b) if so, what will be the expenditure on this account;
- (c) whether the nationalised banks have deputed some of their officers to foreign countries for 'specialised training";
- (d) if so, the number of persons already sent and the expenditure incurred by Government thereon; and
- (e) what are the criteria for sending persons abroad for specialised training?

THE MINISTER OF FINANCE (SHRI Y. B. CHAVAN): (a) and (b) Three out of the five Indian commercial banks having, at present, 14 branches in the United Kingdom, have with them licences to open 8 more branches, issued by the Reserve Bank of India, during the years 1972 and 1973. Reserve Bank of India has not, so far during the year 1974. given a new licence to any Indian commercial bank to open a branch in the United Kingdom.

(c) to (e) Public sector banks have been deputing their officers considered suitable by them for training in specialised training abroad. According to the information readily available with the Reserve Bank of India during the years 1969 to 1973, 70 officers  $fro_{T}J$

public sector banks had gone abroad for such training. Expenditure on this account is incurred by the bank concerned and not by the Government of India. The Reserve Bank, has reported that foreign exchange was released by the Reserve Bank to the concerned banks after considering the essentiality of training, age, qualification and experience etc. of the officers concerned.

# Non-Inspection of damaged Aircraft by Aeronautical Inspection Department

- (b) whether it is also a fact (hat this is not the first time that such neglect on the part of the Aeronautical Inspection Department has been brought to Government's notice:
- (c) whether any action is being taken against persons responsible for such deduction of duty; and
- (d) if so, what other steps Government propose to take to ensure that safety of the passengers is not jeopardized in this manner?

THE MINISTER OF TOURISM AND CIVIL AVIATION (SHR1 BAHADUR): (a) An Indian Airlines Boeing 737 operating flight IC-251 (Kathmandu-Varanasi) on May 1, 1974 has flown through bad weather and hailstorm and sustained minor damage. On landing at Varanasi it was inspected by the airline's Aircraft Maintenance Engineer and it was found that the outer panel of one window had cracked without hampering visibility, one landing light was damaged and there were some minor dents. As the damage sustained was within permissible Umits for safe-operations, the aircraft was allowed for continue its flight to Delhi.

- (b) No, Sir. There has been no neglect on the part of Aeronautical Inspection Directorate of the Civil Aviation Department *ot* Indian Airlines.
  - (c) and (d) Do not arise.
