# Issue of licence to Mysore Iron and Steel Ltd.

1532. SHRI B.P. NAGARAJA MURTHY" Will the Minister of STEEL AND MINES be pleased to state :

(a) whether it is a fact that the Mysore Iron tnd Steel Ltd. Bhadravati has applied for a licence for the installation of an alloy and high carbon steel wire rod mill of a capacity of 60,000 tonnes per annum in the size range 5.5 to 16 mm; and

(b) if so, what arc the det.iils thereof and the decision taken by Government thereon ?

THE DEPUTY MINISTER IN THE MINISTRY OF STEEL AND MINES (SHRI SUBODH HANSDA): (a) Yes, Sir.

(b) A feasibility study >f the scheme is being prepared by Metallurgical and Engineering Consultants (India) Ltd., and details will become available only after this is completed. The scheme is estimated to cost about Rs. 15 crores. The wire rods produced will be utilised by wire re-drawing industries for the pr >duction of wires of various sizes. The company have been granted a letter of intent valid for one year.

## Mineral resources in Nagaland

1533. SHRI I.T. SINGH : Will the Mini ster of STEEL AND MINES be pleased to state :

(a) whether it is a fact that Nagaland and Manipur along with Indo-Burma border are rich in Mineral rosources; and

(b) if so, whether the Geological Survey of India propose to tap these resources?

THE DEPUTY MINISTER IN THE MINI-STRY OF STEEL AND MINES (SHRI SUKHDEV PRASAD): (a) As a result of geological mapping and investigations carried out by the Geological Survey of India in Nagaland and Manipur, following mineral occurrences have been indicated so far:—

#### Nagaland:

Mineral deposits so far estimated in Nagaland include reserves of 55 million tonnes of coal in Naziia coalfield. Coal has also been located in Jhansidisai coalfield and Lakhuni and Changkikang in Mokokechung District. About 9 millio.i tonnes cf Nickeliferrous Magnetite have been located in Thensang District of Nagaland.

Manipur:

Mineral deposits so far estimated in manipur include reserves of 6.4 million tonnes of marginal Cement grade limestone at Ukhrul, Hundung, Khanggoi and Lumbi in Manipur East District and some lignite with 2.5 million tonnes of clay associated with lignite near Hangvai in Manipur South District.

(b) Regarding utilisation of minerals located in Nagaland and Manipur, the Manipur Government is examining the feasibility of setting up a Cement Plant in the State, based on the limestone deposits. The Nagaland Government is actively considering exploitation of the coal deposits located in the Nazira area of the State.
