Ship building Yard.—Government had appointed a Techno-economic Working Group of officers to examine the various sites recommended by the State Governments. The Working Group evaluated from the technical and economic point of view the various sites recommended and have submitted their report which is under examination. Recently negotiations were also held with certain consultants for preparation of preliminary project reports on the various sites found suitable by the Techno-Economic Work-ins Gioup. A final decision in the matter will be taken by the Govern-

Under-utilisation of Port's capacity to handle Iron ore should he rectified and increased capacity should he created.—
This matter has been taken up with the Railways and the Minerals and Metals Trading Corporation to ensure better movement of ore. Separately, it has been assessed that by the end of 5th Plan Period, Paradip may be handling 4-5 million tonnes of Iron ore. It will be possible to do so by improving the handling capacity of the existing plant.

Development of Paradip Township.— This is linked with the question of transfer of land to the Port Trust by the State Government. This was recently discussed with the Government of Orissa who have been urged to find an early solution to this matter.

Financial help to the Port.—L )ans for development, as per assessed requirements, are given.

For meeting other liabilities, ways and means advances are also given.

expenditure on repairs to ships and purchase of spares upto £ 1,000 in respect of vessels of less than 30,000 GRT and upto £ 2,000 in respect of vessels of 30,000 GRT and over without obtaining the prior approval of the Government.
