That case is pending trial since then.

(b) and (c) A National Census of small scale industries is currently in progress and the information regarding employment and investment in these units covered by the Census is expected to be available by the end of 1974.

- (a) what is the target fixed in regard to enhancing the annual income of persons belonging to the lowest strata of society as a result of development programmes and policies during the Fifth Five Year Plan; and
- (b) what are the main features of development programmes and policies in this regard during the Fifth Five Year Plan?]

#### विवरण

(क) पां चवीं योजना अविध के दौरान अपनाई जाने वाली नीति तथा विकास कार्यक्रमों के फलस्वरूप समाज के निम्नतम स्तर के लोगों की वार्षिक आय में वृद्धि के संबंध में पांचवीं योजना प्रारूप में कोई विणिष्ट लक्षय परिकल्पित नहीं किये गये हैं। तथापि पांचवीं योजना के प्रारूप में, जोिक गरीबी हटाने के उद्देश्य से बद्ध है, यह आशा की गयी है कि जनसंख्या के निम्नतम 30 प्रतिशत के प्रति व्यक्ति उपभोगता के वार्षिक औसत में उल्लेखनीय वृद्ध होगी।

- (ख) विकास कार्यक्रमों की विशेषतायें तथा उपर्युक्त उद्देण्य को प्राप्त करने की नीतियों में ये शामिल हैं:---
  - (1) कुल घरेलू उत्पादनों की सब मिला कर 5.5 प्रतिशत वृद्धि दर।
  - (2) जन उपयोग की वस्तुओं के अधिक उत्पादन तथा अधिक कारगमी वितर्ण पर बल।
  - (3) उत्पादनात्मक रोजगार के स्रवसरों का सृजन विशेष रूप से एस० एफ०डी०ए० सुखा प्रवृत्त क्षेत्र कार्यक्रम आदि जैसे कार्यक्रमों के माध्यम से कृषि तथा सम्बद्ध क्षेत्रों में ।
  - (4) खाद्यान्नों तथा अन्य आवश्यक वस्तुओं की सार्वजनिक वसूली तथा वितरण पद्धति का सुद्ढ़ीकरण।
  - (5) न्यूनतम आवश्यकता के राष्ट्रीय कार्यक्रम के क्रियान्वितीकरण के द्वारा मामाजिक उपभोगता में वृद्धि।
  - (6) पिछड़े हुए वर्गो तथा क्षेत्रों के उत्थान के लिए विकास कार्यक्रमों का क्रियान्वयन।
  - (7) सामाजिक, आर्थिक तथा क्षेत्रीय ग्रसमानताओं को कम करने के लिए संस्थात्मक राजकोषात्मक तथा अन्य उपायों को अपनाना।
  - (8) अमीरों के अनावश्यक तथा संदिग्ध उपभोग पर सख्ती से नियंत्रण ।
  - (9) परिवार नियोजन कार्यक्रम को तेज करना।

#### Statement

(a) The draft Fifth Plan does not envisage a specific target in regard to the increase in the annual income of the persons

belonging to the lowest strata of society as a result of development programmes and policy to be adopted during the Fifth Plan period. However, the Draft Fifth Plan, consistent with the objective of removal of poverty, stipulates significant increase in the average annual per capita consumption of the lowest 30% of the population.

- (b) The features of development programmes and policies to achieve the above objective include:—
  - (i) a 5.5 per cent overall rate of growth of gross domestic product;
  - (ii) an emphasis on increased production and more effective distribution of mass consumption goods:
  - (iii) generation of productive employment opportunities, specially in agricultural and allied fields; through such programmes as SFDA/Drought Prone Areas programme etc;
  - (iv) strengthening public procurement and distribution system for foodgrains and other essential commodities:
  - (v) increase in social consumption through implementation of National Programme of Minimum Needs;
  - (vi) execution of development programmes for the up-lift of backward classes and regions;
  - (vii) adoption of institutional fiscal and other measures for reduction of social, economic and regional disparities:
  - (viii) vigorous restraint on inessential and conspicuous consumption of the rich; and
  - (ix) intensification of family planning programme.]
