based on the needs of external institutions, industries and Government.

- 14. Long-term, selected groups should be brought to NID for more intensive and specific exposure.
- 15. The NID must initiate its own research and undertake assignments for others and cover both fundamental and applied research.
- 16. Projects and assignments should have relevance to the institute's teaching and research programmes. There must be a separate devision for this purpose. Payments should be made to the Institute but a formal system evolved for distribution of a portion of the fees. The payments should mainly help fund NID research and part of it may be spent on improving amenities. The division must be self supporting.
- 17. The benefits of designs must be quickly demonstrated. A liaison facility needs to be established within the NID which will be incharge of external communica-tio nand feed
- 18. Extension centres should be set up in metropolitan cities in association with State Small Scale Industry establishments.
