#### WRITTEN ANSWERS TO QUESTIONS

##### Applications under the "Own your Telephone Scheme in Madras"

\*215. SHRI S. A. KHAJA MOHIDEEN: Will the Minister of Communications be pleased to state:—

(a) the number of applications on the waning list in Madras under the scheme 'Own your telephone' at present; and

(b) what steps Government have taken to minimise the waiting period for such telephone connections?

THE MINISTER OF COMMUNICATIONS (SHRI K. BRAHMANANDA REDDI): (a) and (b) 62 applications under OYT category were pending in Madras on 1-2-1974 as against a total waiting list of 11,191.

These applications are pending for want of exchange capacity, requisite stores and materials. Within restricted available resources of equipment and material every effort is being made to expand the telephone system so as to provide more connections. An additional capacity of 12,900 lines is expected to be added to Madras Telephone system during the Fifth Five Year Plan which may more or less clear the entire existing waiting list.

THE MINISTER OF INDUSTRIAL DEVELOPMENT AND SCIENCE AND TECHNOLOGY (SHRI C. SUBRAMANIAM): (a) to (c) The progress of conversion of Letters of Intent into industrial licences is being reviewed on an industry-wise basis from time to time. Such reviews are also conducted on a State-wise basis periodically. Letters of Intent on which there has not been adequate progress within the validity period are allowed to lapse or are cancelled. The number of Letters of Intent cancelled/lapsed/surrendered etc.. in the years 1972, 1973 and 1974 (upto 31-3-1974) is as follows
