

(b) if so, what are the details thereof?

**THE MINISTER OF COMMERCE (PROF. D. P. CHATTOPADHYAYA):** (a) & (b) In view of the recent increase in oil prices and other essential imports the Government has prepared a programme of exports for all countries including oil producing countries in the Persian Gulf Area and elsewhere. The crash programme envisages increase in exports of both traditional and non-traditional items.

The principal elements of the programme are:

(a) Identification of products with maximum export potential in the immediate future,

(b) Identification of destination to which exports of these products would yield maximum unit value realisation, and

(c) Identification of measures which would augment the domestic production base and generate additional export surpluses for these products.

As a result of the crash programme it is expected that exports during the current financial year will be substantially higher than the rate of 7.6 per cent. envisaged in the draft Fifth Five Year Plan document. The exports to the oil producing countries including in the Persian Gulf Area are likely to be more than double during 1974-75 as compared to 1972-73 level.

#### **Take-Over of Andrew Yule & Co.**

assets and investments of Andrew Yule and Co. Ltd. has since been completed by National Industrial Development Corporation Ltd., a Government of India Undertaking.

**THE MINISTER OF FINANCE (SHRI Y. B. CHAVAN):** (a) and (b) No specific request for additional grants to reduce the budget deficits and to meet the Plan expenditure has been received from the State Governments. However, some of them have approached for Central assistance for meeting their carry-over deficits and for assistance outside the Plan for specific projects.
