THE MINISTER OF FINANCE (SHRI Y. B. CH A VAN): (a) and (b) The United Nations Development Programme (U.N.D.P.) renders its assistance to developing countries on the basis of the "Country Programme" proposed by each recipient country. India's "Country Programme" was approved by the UNDP Governing Council in June 1972 for an Indicative Planning Figure of \$50 milion and for the five-year period 1972-76. Our Country Programme had been formulated in close consultation with the Planning Commission and the various Ministries, who were required to take into account the needs of the State Governments and Union Territories while proposing schemes for inclusion in the Country Programme. The State Governments and Union Territories were also advised to furnish to the concerned Ministries their proposals for UNDP assistance. No developmental scheme relating to any State in the North Eastern Region was, however, sponsored for inclusion in the Country Programme.
