SHRI GUNANAND THAKUR:

Will the Minister of COMMERCE be pleased to state:

- (a) the names of cosmetics and other luxury items for the production of which raw materials were imported during the years 1972-73 and 1973-74; and
- (b) the steps Government propose to take to stop such imports?]

वाणिष्य मंत्रालय में उपमंत्री (श्री ए० सी० जाजं): (क) 1972-73 तथा 1973-74 के दौरान फेस कीमंह्म्नो, टैल्क, टायलेट पाउडर, फेस पाउडर, हैयर आयल्स, शैम्पो, लोशनों ब्रादि जैसे सौन्दर्य प्रसाधनों के उत्पादन के लिए कतिपय आवश्यक कच्चे माल के ब्रायात करने की अनुमति दी गई थी। "विलास की वस्तुएं" शब्द बहुत व्यापक है, इसलिए विलास की वस्तुश्रों का विशिष्ट संकेत देना जरूरी है।

(ख) जैसे ही और जब देश में उपर्युक्त स्वदेशी स्थानापन्न वस्तुएं उपलब्ध हो जाएगी, स्रावश्यक कच्ची सामग्रियों के स्रायात धीरे-धीरे बन्द कर दिए जाएंगे।

†(THE DEPUTY MINISTER IN THE MINISTRY OF COMMERCE (SHRI A. C. GEORGE): (a) For production of cosmetics items like face cream/snow, talc, toilet powder, face powder, hair oils, shampoo, lotions etc. certain essential raw materails were allowed to be imported during 1972-73 and 1973-74. The term 'luxury items' being a very wide one, it is necessary to have a specific indication of luxury items.

(b) The imports of essential raw materials will be stopped gradually as and when suitable indigenous substitutes become available in the country.]

Decision on pending recommendations of Third Pay Commission

Will the Minister of FINANCE be pleased to state:

- (a) whether it is a fact that decision on certain recommendations of the Third Pay Commission, especially relating to House Rent Allowance, City Compensatory Allowance and Children Education Allowance has not yet been taken;
- (b) if so, the reasons for the delay and by when the decision is likely to be taken; and
- (c) whether the recommendations are to be given effect to from the 1st January, 1973 and if not, the reasons therefor?

THE MINISTER OF FINANCE (SHRI Y. B. CHAVAN): (a) to (c) The decisions of Government on the recommendations of the Third Pay Commission relating to pay scales, allowances, retirement benefits etc. in respect of civilian employees of the Central Government in Classes II, III and IV were notified in Resolution No. 70(34)/ 73-Imp. Cell dated 1-11-1973 published in Part I Section I of the Gazette of India Extraordinary No. 257 dated 1-11-1973, copies of which have been placed in the Parliament Library on the 8th November, 1973. The Commission had recommended 1-3-1973 as the date of giving effect to its recommendations on pay scales and pensionary benefits. This was modified by Government as 1-1-73. In respect of other matters, no date of effect has been recommended by the Commission. The normal procedure in this regard is that any revision of orders relating to benefits to Government
