Suresh Kumar & Co. and the contract was accordingly modified in their name. Shri Suresh Kumar was not a partner of M/s Mahendra Nath & Co. at the time of rescinding the contract.

# **Enquiry into the Supply of adulterated fertilisers**

Will the Minister of AGRICULTURE be pleased to refer to the reply to Starred Question No. 320 given in the Rajya Sabha on 6th March, 1974 and state;

- (a) whether the enquiry into the scan-da! of supplying adulterated fertilizers to the farmers in Punjab and other places has since been completed;
- (b) if so, how many persons were found guilty and what action was taken against them;

- (c) whether a copy of the inquiry re port will be placed on the Table of the House; and
- (d) if not, what are the reasons there for?]

कृषि मंत्रालय में राज्य मंत्री (श्री अण्णासाहेब शिन्दे:) (क) से (घ) एक विवरण सभा पटल पर रख दिया गया है।

## विवरण

पंजाब को मिलावटी उर्वरकों की कथित सम्लाई के संबंध में भारतीय खाद्य निगम के खिलाफ किसी औपचारिक जांच का आदेश नहीं दिया गया है। तथापि, इस मामले के बारे में पंजाब सरकार की शिकायत पर जांच-पड़ताल की गई थी और यह पता चला कि कुछ बोरियों में बुहारन और अन्य अशुद्ध तत्व मिले हुए हैं। यह जान-बूझकर मिलावट करने का नहीं बिल्क भारतीय उर्वरक निगम के संबंधित मजदूरों और स्टाफ द्वारा समुचित सावधानी न वरतने का मामला था। भारतीय उर्वरक निगम से कहा गया है कि वह यह सुनिश्चित करे कि भविष्य में बोरियों में उर्वरक भरने और उसे प्रेषित करते समय ऐसी लापरवाही न होने पाय ।

जहां तक आयातित उर्वरकों के कम भार का संबंध है, पंजाब से प्राप्त शिकायत की जांच पड़ताल करने पर उसे सत्य नहीं पाया गया । तथापि, कम भार के बारे में विभिन्न राज्यों से समय-समय पर शिकायतें प्राप्त होती रहती हैं तथा उनकी छान-बीन करके उपयुक्त कार्यवाही की जाती हैं । बंदरगाहों पर खुले उर्वरकों की मशीनों की सहायता से बोरों में भर ने और लदान करने की पढ़ित को अपना कर ऐसे मामलों के निवारण के लिए भी कार्यवाही की जा रही हैं।

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI ANNASAHEB P. SHINDE): (a) to (d) A statement is laid at the Table of the

Sabha.

#### Statement

No formal enquiry has, been ordered against the Food Corporation of India in respect of the alleged supply of adulterated imported fertilizers to Punjab. However, the complaint from Punjab Government regarding this case was investigated and it was found that a few hags contained sweepings and other impurities. This was not found to be a case of deliberate adulteration but one c{ lack of proper care on the part of the concern:d FCI labour and staff. The FCI has been asked to ensure that such careless bagging and despatches are avoided in future.

As regards under-weight in imported fertilizers, the complaint received from Punjab was investigated and was found not to be substantiated. However, complaints regarding under-weight are received from time to time from various State Governments and they are investigated and suitable action taken. Action is also being taken to obviate such cases by introducing mechanised handling of bulk fertilizers at ports.]

#### **Sugarcane Prices**

•321. SHRI K. P. SINGH DEO : SHRI LOKANATH MFSRA: SHRI SHYAMLAL GUPTA:

Will the Minister of AGRICULTURE be pleased to state :

- (a) whether it is a fact that sugarcane prices have remained more or less sta tionary while sugar prices in the open market doubled during the last three years; and
- (b) if so what measures Government are taking to bring parity between agricultural and industrial prices of sugar?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI B. P. MAURY A): (a) During the last three years not only has there been an overall increase of about 20% in the minimum cane prices but also the cane prices actually paid were much higher than the notified prices. The open market prices of sugar dependent on various other factors besides cane prices,

have also gone up, mainly because of the increase in Excise duty, the rise in costs of production, increasing pressure of internal demand etc.

(b) The question of fixing of minimum cane prices for 1974-75 season, keeping in view the factors specified under clause 3 of the Sugarcane Control Order, 1966, is under consideration of the Govergment.

### Selling of tickets by Government aided schools in Delhi for the School Mass Physical Training Shows

- (a) whether it is a fact that some well-known Government aided schools in Delhi such as the Lady Irwin School for Girls, New Delhi, are selling every year tickets through their students for the School Mass Physical Training Shows and thus collecting large sums of money ' for building fund;
- (b) whether it is a fact that the school is collecting Rs. 5 every month as compulsory contribution from each student to the building fund on the basis of some Parent-Teachers Association Resolution;
- (c) whether it is a fact that students who do not pay the so-called compulsory monthly contribution or sell the P.T. Show Tickets for the building fund, they and their parents are harassed and humiliated by the Principal and the teachers of the school; and
- (d) if so, what step's Government propose to take to prevent the unauthorised collection of building fund by pressure and coercive methods resorted to by such schools?

THE DEPUTY MINISTER IN THE MINISTRY OF EDUCATION AND
