prior to 1960 and post-matric scholarships had been awarded to the students belonging to such classes;

(b) whether Government propose to ask the State Governments to prepare fresh lists of economically and educationally backward classes; and

(c) if so, the details of the special educational facilities proposed to be given to the children belonging to the socially and economically deprived section of the community by Government in the Fifth Five Year Plan?

THE DEPUTY MINISTER IN THE MINISTRY OF HOME AFFAIRS (SHRI F. H. MOHSIN): (a) Prior to 1963-64 postmatric scholarship to Other Backward Classes were given on the basis of lists prepared by the State Governments/Union Territories. The Ministry of Education had consolidated lists of these communities in respect of the various States/Union Territories for this purpose.

(b) and (c) No Sir, No special facilities are envisaged for the weaker Sections other than Scheduled Castes/Tribes, on community basis.
