†[THE MINISTER OF EXTERNAL AFFAIRS (SARDAR SWARAN SINGH): During her visit to Iran from April 28 to May 2, 1974, the Prime Minister discussed bilateral relations as well as international questions of mutual interest with the Shahanshah of Iran, the Prime minister of Iran and other Iranian leaders. These discussions revealed an identity of views on several international issues such as the west Asia problem; the concept of the Indian Ocean as a zone of peace; support for the principle of non-interference in the internal affairs of other nations and the need for cooperation among all Asian and African countries in economic and commercial fields and for measures to mitigate the impact of rising prices of commodities on developing countries.]

In regard to Sub-continental matters the Iranian side appreciated the initiative taken by India and expressed satisfaction over the conclusion of the tripartite agreements and efforts to settle outstanding disputes by direct negotiations and peaceful means.

Agreements were reached for greater collaboration between the two countries in several fields such as the expansion of the Kudremukh iron ore project setting up a joint shipping line, increasing industrial production in India especially of cement, sugar, billets and steel products, paper and newsprint and chemicals. Iran has agreed to extend soft loans and financial facilities for these purposes. India has agreed to provide technicians, engineers, professors and doctors to Iran. The two countries will also cooperate in the field of use of atomic energy for peaceful purposes.]

### Displaced Persons Living in Government Camps.

\*380. SHRI JAIRAMDAS DAULATRAM: Will the Minister of SUPPLY AND REHABILITATION be pleased to state:

(a) the number of displaced persons from erstwhile East Pakistan living in Government Camps in West Bengal and Tripura at present;

(b) what's the amount sanctioned for their relief and rehabilitation;

(c) what is the national status of these persons; and

(d) what's the break up of the displaced persons who came to these camps before, during and after Bangladesh-Pakistan war, 1971?

THE MINISTER OF SUPPLY AND REHABILITATION (SHRI R.K. KHADJILKAR): (a) The number of displaced persons from erstwhile East Pakistan living in Government Camps in Tripura as on 27-4-74 is 878 families comprising of 2819 persons. There is no Government Camp in west Bengal for migrants from erstwhile East Pakistan.

(b) An amount of Rs. 4.5 lakhs has been sanctioned for various non-agricultural schemes for resettlement of 150 new migrant families living in Camps in Tripura.

For relief benefits for camp families in Tripura an amount of Rs. 5.10 lakhs has been provided in the Budget Estimates for the year 1974-75.

(c) These families are to be considered for Indian citizenship as and when they apply for it.

(d) All the families now in Camps in Tripura migrated to India before 25-3-1971.

(b) A statement giving the required information is laid on the Table of the House.

#### Statement

In the two meetings of the High Level Committee on Coal Transportation and Distribution the following main recommendations were made:—

(i) Increase in the availability of wagons for loading for steel plants and washeries.

(ii) Setting up of a joint Monitoring Cell to ensure that the difficulties faced from day to day in the movement of wagons at the mines, the washeries and the steel plants are solved as expeditiously as possible and an increased level of loading is achieved quickly and maintained.

(iii) Steel Plants and mines to make an all out effort to reduce the detention of wagons within the steel plants, washeries and mines.

(iv) Every effort should be made to meet the coal requirement of power stations, cement, railways and other major industries.

(v) Efforts should be made to increase the production of soft coke.

(vi) Movement of soft coke by road to destination in West Bengal and Bihar to be encouraged.

(vii) Increase in wagon availability for movement of various types of coke.

(viii) Establishment of coal dumps at important locations in different States.

(ix) Ministry of Shipping and Transport to study in depth a scheme for the transportation of coal by inland waterways.

(x) Ministry of Shipping and Transport to take steps for increasing coastal movement of coal.

#### Indo-Iranian Agreement on Kudremukh Project

MALAVIYA) : (a) and (b) : During the recent visit of the Prime Minister to Iran, an understanding has been reached in regard to development of Kudremukh Iron Ore deposits. The Project will be planned for a production of capacity of 7.5 million tonnes of concentrate per year. Iran is expected to take the entire production and to provide finance for the development of this project. The detail will be worked out in due course.
