Royalty for crude oil to Gujarat

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND CHEMICALS (SHRI SHAH NAWAZ KHAN): (a) and (b) According to the Prime Minister's award, which was based on a settlement between the Central Government and the Governments of Assam and Gujarat, the rate of royalty was fixed at Rs. 15 pertonnefrom 1-1-72 to 31-3-79. It is not proposed to change the rate at this stage.
