THE DEPUTY MINISTER IN THE MINISTRY OF COMMERCE (SHRI A. C. GEORGE): (a) to (c) The Federation of Associations of Small Scale Industries of India made a large number of suggestions for changes in the import policy for 1974-75 period. All these suggestions were considered in detail at the time of review of import policy for the year 1974-75 and wherever possible the suggestions have been accepted subject to the availability of foreign exchange and the importance of the user industries to the national economy as also the needs of export production.

THE DEPUTY MINISTER IN THE MINISTRY OF FINANCE (SHRIMATI SUSHILA ROHATGI): (a) The amounts of old claims outstanding and unclaimed written back by the LIC during the years 1970-71, 1971-72 and 1972-73 are Rs. 148.83 lakhs, Rs. 254.61 lakhs and Rs. 71.82 lakhs respectively. Figures for the year 1973-74 are not available at present.

(b) The LIC is alive to the need for settling the claims expeditiouly. Whenever necessary, it sends its field staff to trace the claimants and the LIC officials render necessary assistance to such claimants as are not able to comply with the requirements
