estimate of the Government about this perpetual shortfall year-wise? Why is this long-term contract? They are afraid that we will have a shortfall perpetually. If it is a perpetual shortfall, what is the quantity year-wise?

SHRI ANNASAHEB P. SHINDE: I do not think the question should be posed like this. Our experience in the international market is this. We have such a vast chunk of population and we are such a big country. In the world today because of the population pressure and a number of other factors, there is shortage and imbalance in the food food economy is developing. There is considerable pressure on price. I hope that nobody would exploit our difficulties and I do think that it is in the national interest to have some arrangements, arrangement at the moment contemplated is with Australia. Because their reserves are low and they are not sure about their crop prospects, they are not at the moment prepared to enter into long-term arrangements.

श्री राजनारायण : श्रीमन्, मैं यह जानना चाहता हूं कि रूस से जो गेहूं हमारे यहां आ रहा है, करीब 20 लाख टन का मामला है, वह क्या है रूस उसका पक्षा लेगा या वह तोहफा है ?

SHRI ANNASAHEB P. SHINDE: It has been a very generous offer on behalf of the Soviet Government. They have given it on loan, to be returned after a particular period.

श्री रबी राय: अ।प गेहं देंगे या पैसा देंगे ?

SHRI ANNASAHEB P. SHINDE: It has to be returned in wheat. It is a wheat loan.

MR. CHAIRMAN: The Question Hour is over;

SHRI KRISHAN KANT: Sir we wanted to follow this question as long back as 1973. There was no time in this House. We have not discussed the Government's policy on wheat which came up after the Rajya Sabha adjourned. So, I would request you—and we have given notice—that time should be allotted for discussing the new policy on wheat.

SOME HON. MEMBERS: Yes, yes. MR. CHAIRMAN: I will consider, if you have given notice.

THE MINISTER OF WORKS AND HOUSING (SHRI BHOLA PASWAN SHASTRI): (a) and (b) Applications for allotment of accommodation in the general pool at Delhi/New Delhi are invited on a restricted basis keeping in view the likely availability of houses during a particular allotment year. A statement showing the number of Central Government employees on the waiting list, on the above basis, in each type and the date of priority covered, is laid on the Table of the House.

(c) Only in type IV, employees who entered service in November, 1944 and later are yet to be provided accommodation. Keeping in view the number of vacancies likely to become available, it is expected that it would be possible to provide accommodation to the remaining employees with 'priority' of 1944, by the end of May, 1974.

THE DEPUTY MINISTER IN THE MINISTRY OF EDUCATION AND SOCIAL WELFARE AND IN THE DEPARTMENT OF CULTURE (SHRI D. P. YADAV): (a) and (b) According to the Delhi Administration, about 15 to 20 persons connected with a few local amateur theatre groups staged a silent demonstration on 27-3-1974 when the Sahitya Kala Parishad of Delhi Administration organised a function for 2—12RSS/74

honouring eminent artists and litterateurs and for distributing prizes for acting and production pertaining to Drama. It is learnt that the demonstrators were of the view that the judges appointed by the Delhi Administration had not acted fairly in recommending theatre prizes.
