REDDY): (a) and (b) Indian Airlines have not discontinued carriage of mails. Compared to the transit time when the Indian Airlines was functioning normally, the transit time during the IA strike or lockout was more. With the additional sei-'ices introduced from 18-3-74, there has been improvement. The pre-strike or lock-out position will be restored when the Might Air Mail Service resumes, for which close liaison is being maintained with the Indian Airlines.
