THE MINISTER OF STATE IN THE MINISTRY OF PLANNING (SHRI MO-HAN DHARIA): (a) Yes, Sir. The Assam Sovernment have sent their draft Fifth Five Year Plan for the development of Scheduled Castes, Scheduled Tribes and other Backward Classes.

- (b) The State Government has drawn up an integrated programme for the Development of Backward Classes indicating flow of funds from sectoral programmes to the backward communities. The proposals highlight the resettlement of shifting cultivators, preparation of a regular record of rights as a part of the land reforms programmes, development of forestry through rubber plantations in selected areas, communications, health services in tribal blocks, educational programmes to cover 100 per cent enrolment of children under the Minimum Needs Programme and provision of residential primary schools in the most sparsely populated areas, hostels for middle schools and comparatively less sparsely populated areas, stipends, scholarships for all students belonging to backward classes and residential accommodation for teachers. Also, the State Government propose to formulate programmes for the most backward classes among the scheduled castes such as scavengers, flayers, tanners, etc.
- (c) The plans submitted by the State Gavernment are under the consideration of the Planning Commission.

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS AND IN THE DEPARTMENT OF PERSONNEL (SHRI RAM NIWAS MIRDHA): (a) and (b) According to information received from the Government of Uttar Pradesh, some including members of Backward Classes and Scheduled Castes, who hailed from districts Ballia, Azamgarh and Bahraich of Uttar Pradesh as also from some parts of Bihar, came to village Achalnagar within the jurisdiction of Itiathok P.S., district Gonda in January, 1974. They constructed thatched huts on an uncultivated piece of land. Some Thakurs of the village claimed that the land in question belonged to them. On the morning of the 26th March, 1974, a group of persons was alleged to have raided and set on fire seventynine huts belonging to members of Backward Classes and Scheduled Castes. The

police reached the spot the same afternoon and registered a case. Five accused persons have been arrested and arms licences of 7 persons have been seized. In order to prevent a further breach of peace, the land in dispute has been attached U/S 145 Cr. P.C. The police force in the locality has been strengthened to ensure that there is no clash between the two parties. The Station Officer, P.S. Itiathok has been placed under suspension for failure in taking adequate preventive action while the second Officer and Head Moharir have been transferred to the lines. Steps are also being
