

### Setting up of a Coal Corporation in Madhya Pradesh

**\*143. SHRI SAWAISINGH SISODIA :**

Will the Minister of STEEL AND MINES be pleased to state :

(a) what is the quantity of coal produced in Madhya Pradesh; and

(b) whether any coal Corporation is proposed to be set up in that State under the aegis of the Central/State Government; and

(c) if so, what are the details thereof ?

**THE MINISTER OF STEEL AND MINES (SHRI K.D. MALAVIYA) :** (a) The quantity of coal produced in Madhya Pradesh during 1973-74 was of the order of 15 million tonnes.

(b) No, Sir.

(c) Does not arise.

### Policy on Export of Metals

**\*144. SHRI J. S. ANAND :** Will the minister of STEEL AND MINES be pleased to refer to the answer to Starred Question 636 given in the Rajya Sabha on 22nd March, 1974 and state :

(a) whether Government have taken final decision about the ore export policy to conserve metals for the country's requirements; and

(b) if so, what are the details thereof ?

**THE MINISTER OF STEEL AND MINES (SHRI K. D. MALAVIYA) :** (a) & (b) The export policy in regard to ores is kept continuously under review. Export of metallic ores with the exception of iron ore is allowed on a restricted basis taking into consideration the indigenous requirements, Export of iron ore is allowed from deposits not linked to any steel plant.

### Indian Consulates in Bangladesh and Bangladesh Consulates in India

**THE MINISTER OF EXTERNAL AFFAIRS (SARDAR SWARAN SINGH) :** (a) Besides the consular Wing attached to the High Commission in New Delhi, Bangladesh has a Deputy High Commission in Calcutta, which also performs consular functions.

(b) Besides the Consular Wing attached to our High Commission at Dacca, we have an Assistant High Commission at Chittagong, which also performs Consular functions.
