THE DEPUTY MINISTER IN THE MINISTRY OF FINANCE (SHRIMATI SUSHILA ROHATGI): (a) The audits of the accounts of the nationalised banks for the year 1973 have been nearly completed by the statutory auditors and the baiance sheets and profit & loss accounts of the banks will shortly be placed before the respective Boards of Directors of the banks for adoption.

(b) Details of the bank-wise profits will be known after adoption of the accourts by the respective Boards.

Development of Tourism in Rajasthan

In addition the India Tourism Development Corporation proposes to construct a 100-room hotel at laipur at an estimated cost of Rs. 135 lakhs during the Fifth Plan Bharatpur, Deeg, Jaipur and Jaisalmer have been included for development under the Cultural Tourism programme of the Department of Tourism in the Fifth Plan. The details of the schemes have yet to be finalised in consultation with the State Government and other agencies concerneđ.

Parity between Cotton and textile prices
