(a) whether Government's attention has been drawn to a news-item which appeared in the 'Economic Times' of 25th December, 1973 to the effect that 30,000 workers had been laid off in Kanpur;

IHE MINJS1ER QF LABOUR (SHRI K. V. RAGHUNATHA REDDY): (a.) to (c) A report in the matter was called for from the Government of Uttar Pradesh. According to the informatiin made a\ail-able by them. 23.517 workers were laid off in Kanpur during November 1973, of which 23,443 were cases of lay off due to power cuts and ihe remaining 74 due to other causes. The State Government have made efforts to provide as much power to the industries as possible.
