(a) and (b) The scheme envisages production of an additional 1,28,500 tonnes of nitrogen per annum. The project is estimated to cost about Rs. 89 crores. The scheme will use fuel oil as the feedstock, in lieu of Coke/Coke over gas presently in use as feedstock at Sindri.
