(c) and (d) Despite adverse features affecting train operation during the period under consideration, movement of higher priority salt, like programmed and industrial salt was maintained at a satisfactory level. Non-programmed salt is cleared under the lowest priority class 'E' and consistent with the commitments of the railways to move higher priority traffic like imported foodgrains and fertilisers on preferential basis from the Gujarat Ports, every effort is being made to maximise loading of non-programmed salt also.

. FABO 6. A Oil Policy

467. SHRI SUNDAR MANI PATEL: SHRI LOKANATH MISRA: SHRI DEBANANDA AMAT: SHRI K. P. SINGH DEO:

Will the Minister of PETROLEUM AND CHEMICALS be pleased to state:

- (a) whether in the light of the policy of oil producing countries, Government are planning to reorient their oil policy;
- (b) if so, the details of the new strategy; and
- (c) whether it would in any way affect saving in oil consumption; and if so, to what extent?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND CHEMICALS (SHRI SHAH NAWAZ KHAN): (a) Yes, Sir.

(b) and (c) Bi-lateral contacts are being established with the oil producing countries with a view to maintaining continuity in supplies of crude oil and softening the impact of steep increases in prices. Efforts have also been intensified to explore and develop crude oil production in the country both on land and off-shore. In the meanwhile, inter alia, non-essential consumption of oil products is being curbed to the extent feasible and all possible efforts are being made to develop alternative sources of indigenously available fuels, which will supplement oil for meeting the growing energy needs of the various sectors of the economy of the country. Final decisions will be taken in the light of the report of the Fuel Policy Committee which is expected shortly. It is difficult, therefore, to precisely estimate the extent of savings.

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND CHEMICALS (SHRI SHAH NAWAZ KHAN): (a) and (b) Government have appointed a Committee for examining the technical and other aspects in connection with the development of rock-phosphate deposits in the Jhamarkotra area in Rajasthan. The Committee is expected to start functioning shortly. The terms of reference of the Committee are as follows:

- (i) to evaluate the feasibility study carried out by the foreign consultant firm and examine all technical aspects involved and specify the further steps that need to be taken for the expeditious and integrated development of the Jhamarkotra rock phosphate deposits; and
- (ii) to suggest the most appropriate corporate structure for the development of the deposits after taking into consideration the magnitude of the investment involved and the method of financing.
