THE DEPUTY MINISTER IN THE MINISTRY OF COMMERCE (SHRI A. C. GEORGE) : (a) and (b) The Indo-Nepal Joint Review Committee held its third meeting in New Delhi from 26 December 1973 to 4 January 1974. The Committee discussed matters relating to transit facilities for Nepal's trade with third countries, provision of warehousing facilities at Calcutta Port, refund of excise duties on Indian exports to Nepal, supply of essential commodities to Nepal, the ban imposed by Nepal on foreign firms trading with third countries, deflection of Indian goods to third countries *via* Nepal, etc.
