

coal through coastal shipping on a large scale to enable them to switch over from oil to coal as energy source both in industries and agriculture has been received. However in August, 1973 a request from the Government of Gujarat for allotment of collier on account of Gujarat Small Industries Corporation was received and one vessel was accordingly allotted to carry coal. Certain requests have also been received from industries located in Gujarat for movement of coal on their account. D. G. Shipping has been allotting vessels to industries located in Gujarat after meeting the minimum requirements of railways for movement of coal and other priority requirements.

Statement

The question of maximum utilisation of the irrigation potential in the country has been under consideration of the Govt, of India for some time past. This question has also been considered by the Irrigation Commission and the National Commission on Agriculture. It is felt that it has not so far been possible for the beneficiaries to derive optimum advantage from such facilities on account of the non-availability of assured and regular supplies ia certain irrigation systems to meet the changed requirements of the present day agriculture pointing to the necessity cf taking expeditious steps to modernize the same, the non-construction of water courses and field chanel, the need for land levelling, land shaping and other on-fann works, the non existence of proper drainage systems leading to the problems of waterlogging, salinity and alkalinity, the practice of doing field to field irrigation, the non-adoption of rostering system of irrigation as well as irrigation dining the night and the inadequacy of infrastructure and inputs. The combination of some or all of these factors has led to the under-utilization of the irrigation potential in the case of a very large number of projects. An integrated area development approach has, therefore, been accepted for the Command Area Development Programme in the Fifth Five Year Pian. The programme will vary in scope and extent from project to nroject and State to State depending on the developments that have already taken place and other relevant factors. Detailed surveys and investigations will have to be carried out in the selected commands and comprehensive integrated schemes drawn up. Broadly speaking the programme would cover on-fann development works comprising field channels, field drains, land levelling and land shaping operations, surveys, designs and preparation of plans for these works and supervision of execution thereof; strengthening of existing extension, training and demonstration organisations; provision of adequate main and intermediate drainage ; I modernization of the existing irrigation

systems, where necessary; strengthening of infrastructure viz., roads, markets and processing industries, etc. An appropriate type of a Project Authority to discharge effectively and speedily the functions listed above has been proposed to be set up in each command area. It is proposed to implement the integrated Command Area Development Programme in 50 selected irrigation commands during the Fifth Plan period. The finalisation of the command areas to be included in the programme is under correspondence with the State Governments.

MAURYA) : (a) and (b) An Appraisal Mission of World Bank visited India in October-November, 1973 to appraise project reports under Drought Prone Areas Programme formulated for six districts including Anantpur for Bank assistance. It is likely that World Bank assistance will be forthcoming on the basis of the Appraisal Teams report.

(c) and (d) The components of the Anantpur district Project include development of agriculture, medium and minor irrigation works, cattle and dairy developments, sheep husbandry and afforestation. The details of programme elements, outlays etc. are yet to be settled with the World Bank.
