THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI ANNASAHEB P. SHINDE): (a) and (b) A statement is laid on the Table of the Sabha.

#### Statement

- (a) The position with regard to Statewise allocations of funds for Emergency Agricultural Production Programme (EAPP) as also the State-wise, crop-wise estimates of actual production in 1972-73 vis-a-vis 1971-72 are given in Statement I [See Appendix LXXXVII, Annexure No. 29] and Statement II [See Appendix LXXXVII, Annexure No. 30] respectively.
- (b) Government of India have not received any specific complaints about misutilisation of funds allocated under Emergency Agricultural Production Programme. Information with regard to use of funds' under this programme for purchase of pumpsets in Bihar was asked for from the State Government. They have reported that out of the loan of Rs. 17.73 crores advanced to them under EAPP, Rs. 3.07 crores spent for purchase of pumpsets, which are working satisfactorily and there have been no complaints about their working. These were purchased after inviting tenders on all-Indiabasis from reputed firms and were tested before purchased.

# Shortage of shipping space

- 315. SHRI KALYAN ROY: Will the Minister of SHIPPING AND TRANSPORT be pleased to state:
- (a) whether Government's attention has been drawn to a report which appeared in

- the "Statesman" of 2nd lanuary, 1974 regarding criticism made at the meeting of the Board of Trade about the acute shortage of shipping space affecting exports; and
- (b) if so, what steps Government propose to take to increase the shipping space and port facilities in this respect?

THE MINISTER OF SHIPPING AND TRANSPORT (SHRI KAMLAPATI TRIPATHI): (a) Yes Sir.

(b) The Government have a Freight Investigation Bureau in the Directorate General of Shipping to assist the shippers in securing shipping space.

The national shipping tonnage has to be increased to serve the needs of country's growing trade. The target proposed to be fixed in the Fifth Plan is 86.41 lakhs GRT. This will enable us to carry IOO per cent of our overseas trade in crude oil and petroleum products, 50 per cent of iron ore export to lapan, IOO per cent of iron ore export to Europe and about 50 per cent of the liner trade. The operative tonnage at present is 30.17 lakhs GRT and another 21.97 lakhs GRT is on order. An enlarged programme for development of port facilities has also been included in the Draft Fifth Five Year Plan.
