STATEMENT

- (a) The total number of foreign collaboration proposals approved by the Government of India during the year 1973 was 2.65.
- (b) Out of 265 cases, 231 cases involved only technical collaboration, while the remaining thirty four cases involved a foreign equity participation of Rs. 281.72 lakhs. The collaboration agreements covered, amongst others, the manufacture of metallurgical equipment, electrical equipment, transportation, industrial machinery, machine tools and chemicals.
- (c) The names of countries of foreign collaborators include West Germany, U.K., U.S.A., Japan, Switzerland, France, Italy, Sweden, Czechoslovakia, GDR, Austria, Canada, Denmark, Holland, Netherlands, Australia, Belgium, Hungary, Norway, Poland, USSR, Yugoslavia, Hong-Kong and Bulgaria.
- (d) Government's policy is to permit the remittance of profits and dividends on foreign investments subject to payment of Indian taxes thereon.

- (b) Government recognise the need for controlling and regulating the acceptance of contribution or hospitality from foreign sources by individuals and organisations in the country including persons and agencies associated with the Press. Accordingly the Foreign Contribution (Regulation) Bill 1973 was prepared by the Government and introduced in the Rajya Sabha on the 24th December, 1973.

PROMOTION OF DELHI POLICE PERSONNEL

THE MINISTER OF HOME AFFAIRS (SHRI UMASHANKAR DIKSHIT): (a) to (c). The criteria for promotions have been prescribed in Rules framed under the Indian Police Act and having the force of law. Promotions are made on the basis of the recommendations of duly constituted Departmental promotion committees consisting of Senior police officers. Seniority alone is not the basis for promotion which is criterion there have been supersession in some cases. Representations against supersession are examined on merits and Government interfere if the departmental promotion committee is found not to have adhered to the statutory provisions governing promotions.
