THE MINISTER OF PETROLEUM AND CHEMICALS (SHRI D. K. BOROOAH): (a) There are five units manufacturing P.V.C. in the country.

- (b) and (c) The major raw material viz., Naphtha or Alcohol or Calcium Carbide and Hydrochloric Acid or Chlorine are mainly indigenous.

Fuel Policy

*98. SHRI N. G. GORAY: Will the Minister of PETROLEUM AND CHEMICALS be pleased to state:

- (a) whether Government have formulated any fresh policy in view of the high increase in the prices of crude oil from Persian Gulf countries; and
- (b) the steps taken by Government to maintain the production level in the industrial belt in both the public and private sectors?

THE MINISTER OF PETROLEUM AND CHEMICALS (SHRI D. K. BOROOAH):
(a) Government have set up a Fuel Policy Committee under the Chairmanship of Shri S. Chakravarty, Member, Planning Commission which is expected to submit its report shortly. Policy in this regard will be determined after Government have received and considered this Report.

- (b) Government have taken a number of interim measures which include, *inter-alia*, the following:
 - (i) Maximum possible curbs on nonessential consumption of oil products are being imposed;
 - (ii) Every effort is being made to maintain the supplies to the essential sectors of the economy;

- (iii) Bi-lateral contacts have been established with the oil producing countries in an effort of soften the consequences of the steep increase in prices of crude ail;
- (iv) Intensified efforts are being made to explore and develop crude oil production in the country both on land and off-shore; and
- (v) A co-ordinated plan is being drawn up to develop alternative sources of energy.

The whole matter is now under reconsideration in consultation with the IIP and the marketing oil companies.
