On the other hand the sugar production during 1972-73 (1st October, 1972 to 30th September, 1973) was 38.73 lakh tonnes as against 31.13 lakh tonnes in 1971-72, and the sugar production is expected to be around 45 lakh tonnes during the current season.

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI ANNASAHEB P. SHINDE): (a) to (c) The Government of Kerala have reported about the difficult food situation in the State and requested for increased allocations of rice from the Central Pool. Keeping in view the overall availability of foodgrains in the Central Pool, the relative needs of States, market availabilities and other relevant factors, maximum possible supplies of rice are being made to the State. The Government of Kerala are in constant touch with the Central Government in this regard.

Will the Minister of AGRICULTURE be pleased to state:

(a) whether it is a fact that price of sugar in open market, even though there is ample production as per Government's assessment, has abnormally increased; and

(b) if so, whether Government propose as a short measure to acquire all sugar produced and create sizeable buffer stocks to relieve burden of increasing prices?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI B. P. MAURYA): (a) The production of sugar, no doubt, increased by about 7.6 lakh tonnes during 1972-73, but the benefit of it was more than wiped out by a lesser carry-over from the previous year by about 8 lakh tonnes. Further, 2.5 lakh tonnes of sugar was exported last year as against 1.5 lakh tonnes in the previous one to earn the much-needed foreign exchange. Consequently, the overall availability of sugar for domestic consumption was much less during 1972-73 season. Though the production so far during the current season is somewhat less than what it was during the corresponding period of last season, it promises to pick up and ultimately be better than last year's. This year most of the factories are paying much higher cane prices than the notified minimum, and the cost of manufacturing has increased and the excise duty on free sale sugar has also been increased from 30 to 37.5% from the 15th December. 1973. There is also a general expectation that because of the present oil crisis and the ruling unprecedented high prices of sugar in the world market, exports of sugar would be further increased to the maximum extent possible. On account of these factors, the price of sugar in free market has tended to be high. Movement difficulties from time to time caused by railway strikes and shortage of diesel oil for road movement have contributed further to this trend.

(b) The Government have already accepted, in principal the need for maintaining buffer stocks of sugar, but its implementation will be possible only when the production is sufficient to meet both the demand within the country and the requirements for export. As the partial control policy on sugar has paid rich dividends by way of ensuring better production, higher cane prices for the growers and availability

of reasonable quantity of sugar to consumers at stable price, there is no proposal under consideration to change it.

Shipping service between India and Sri Lanka
