THE DEPUTY MINISTER IN THE MINISTRY OF COMMERCE (SHRI A.C. GEORGE): (a) and (b) Yes Sir. There is a global shortage of nylon yarn and its raw material caprolactum, however, STC is making every effort to locate and purchase as much as possible of nylon yarn to meet the current shortage. A purchase team of STC which was sent for making on-the-spot purchases of caprolactum and nylon yarn has been able to procure some caprolactum only. Efforts are still being made to locate nylon yarn in the world markets.
