He was discharged from service some four years ago. And I am subject to correction. That is why I should be 1 ven time...

SHRI MOHD. SHAFI QURESHI: I am not yielding...

THE VICE-CHAIRMAN (SHRI V. B. RAJU): Mr. Yadıv, do not enter into a dialogue now.

SHRI MOHD. SHAFI QURESHI: That is why I request d the hon. Member that I shall get the full details and submit to him. In case he wants to discuss further, he is welcome to come to me at any time. Sir, with these v ords, I commend the Bill to the House.

THE VICE-CHAIRMAN (SHRT V. B. RAJU): The question is:

"That the Bill to authorise payment and appropriation of certain further sums from and out of the Consolidated Fund of India for the services of the financial year 1973-74 for the purposes of Railways, as passed by the Lok Sabha, be taken into consideration."

The motion was adopted.

THE VICE-CHAIRMAN (SHRI V. B. RAJU): We shall now take up clause by clause consideration of the Bill.

Lok Sabha

Clauses 2 and 3 and the Schedule were added to the Bill.

Clause 1 the Enacting Formula and the Title were added to the Bill.

SHRI MOHD. SHAFI QURESHI: Sir, I move:

"That the Bill be returned."

The question was put and the motion was adopted.
