SHRI BHUPESH GUPTA (West Bengal): We are all disturbed by the news which appeared in the newspapers today. I am reading from the The Patriot:

On the 19th night, a number of Shiv Sena people, described here as hooligans, attacked a number of hotels and indulged in stone-throwing and other activities in different parts of Bombay thereby creating tension between different communities and between various people and also threatening national integration.

We are particularly disturbed by what has appeared in the Maharashtra Times of 20th December. There is a story appearing on the front page under the caption that Bal Thackeray praises Shrimati Indira Gandhi! According to this report last week he was interviewed by the Current, and Bal Thackeray had said that Communists had captured some important positions in the Government. He was asked by Current whether he was trying to come to a common ground between him and the Congress Party. He replied: "I am trying to do so since 1967". Shri Adik who has been put up as a candidate was with Shiv Sena till 1967. I want the Home Minister to consider as to how this deception can .be stopped. The leader of Shiv Sena Bal Thackeray has come to an understanding with the Congress. Bal Thackeray used to write

scurrilous articles against Shrimati Indira Gandhi in the journal he used to bring out. In the Hindustan Times it is stated that the Congress Party has supported the strike and bandh organised by Bal Thackeray ...

SHRI NIREN GHOSH (West Bengal): If he wrote scurrilous articles then, now things have changed.

SHRI BHUPESH GUPTA: My friend has some axe to grind and that is why he is getting up. I am not interested in it. We have been opposed to Shiv Sena activities. It is a matter.of disgrace and shame that the Congress Party in Maharashtra and Bombay City has come to an understanding with them and that has given direct encouragement to Shiv Sena to carry on its campaign. We all know how Jawaharlal Nehru felt about Bal Thackeray and Shrimati Indira Gandhi felt about him and most scandalous things have been written by him about them. Now he has begun to praise Shrimati Indira Gandhi for having come to an understanding with him for" Bombay election. On the one hand you call for national integration. Therefore, Sir, I am saying all these things. You fo-get the political part of it. THE DEPUTY MINISTER IN THE MINISTRY OF FINANCE (SHRIMATI SUSHILA ROHATGI): Sir, I beg to move:

"That the Bill to provide for the authorisation of appropriation of moneys out of the Consolidated Fund of India to meet the amounts spent on certain services during the financial year ended on the 31st day of March, 1972, in excess of the amounts granted for those services and for that year, as passed by the Lok Sabha, be taken into consideration."

This Bill arises out of the Demands for Excess Grants relating to the year 1971-72 voted by the Lok Sabha on 19th December, 1973, and the expenditure 'Charged' d|n the Consolidated Fund of India and incurred in excess of the sanctioned Appropriations for that year. The reasons which led to the excesses have been explained in the footnotes below each Demand or Appropriation in the Statement of Demands for Excess Grants, which was circulated to the Hon. Members on 10th December, 1973.

As the House is aware, excesses over appropriations revealed after the are Appropriation Accounts are compiled Comptroller and Auditor General or the Defence Accounts or Posts Accounts or the Railway Telegraphs Accounts authorities, as the case may be. These excesses are, in the first instance, required to be scrutinised by the Public Accounts Committee under Rule 308(4) of the Rules of Procedure and Conduct of Business in Lok Sabha and It is only after the Committee have looked into the facts of each case and recommended their regularisation that the matter is brought before Parliament. The excesses for 1971-72 were scruti-tnised by the Public Accounts Committee in their sitting held on 1st September, 1973. The Committee have, in Para. 2.55 of their Ninety-sixth Report (Fifth Lok Sabha) presented to Parliament on 4th September, 1973, recommended the regularisation of these excesses.

The demands for which Parliament has been approached for regularisation relate to Civil, Defence Services and Posts and Telegraphs for
