## Nitrogenous Fertilizer

SHRI YOGENDRA MAK-WANA:

WiH the Minister of AGRICULTURE be pleased to state:

- (a) the total production of Nitrogenous fertilizer in the country;
- (b) the demand and requirements of the Nitrogenous fertilizer in the States and allocation thereof during the current year;
- (c) whether it is a fact that there is short supply of fertilizer to the Gujarat State;
- (d) if so, the quantity of short supply, and the reasons thereof; and
- (e) the action taken by Government in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE <SHRI ANNASAHEB SHINDE): (a) The total production of nitrogenous fertilisers in the country is expected to be 11.2 lakh tonnes during the current year i.e. 1973-74.

- (b) A statement showing the quantities of Nitrogenous fertilisers asked by the States, requirements finalised and the supplies made to the States, is attached at Annexure I [See Appendix LXXXVI, Annexure No. 64.]
- '(c) and (d) During Kharif 73 season the State of Gujarat was supplied 88 per cent of its requirements. During the

Rabi 73-74 the supplies to ihe State so far have been 60 per cent of the proportionate commitments. The shortfalls are a part of the shortage of fertilisers being faced by the country, as a result of lags in domestic production and reduced availability of fertilisers from imports.

(e) Steps are being taken to improve the availability position of fertilisers in the country by taking measures, to achieve enhanced domestic production of fertilisers to import maximum possible quantities of fertilisers and to improve the distribution of fertilisers by rationalising the movement etc. Efforts are also being made to step up the supplies of fertilisers to Gujarat.

THE MINISTER OF SHIPPING AND TRANSPORT (SHRI KAMALA-PAT1 TRIPATHI): (a) to (d) The share

of Indian sniping in the overseas trade of the country since 1969-70 is as follows: •---

1969-70-21.34 per cent. 1970-71—19.87 per cent. 1971-72—16.30 per cent.

Ihe figures for 1972-73 are not yet available. The Director General of Shipping, who had investigated the reasons for the fall, attributed it mainly to increased participation of Indian shipping in cross-trades and also to some extent the temporary diversion of some tramp ships and tankers to coastal trade, necessitated by trading conditions which prevailed during 1971-72. At the same time, the overall earnings of Indian Shipping showed a substantial increase of about Rs. 14 crores during 1971-72.

During the 5th Plan, it is proposed to achieve a target of 8.6 million grt. of shipping. It is expected that this Indian tonnage would be adeauate to carry IOO per cent of country's overseas trade in crude oil and petroleum products, 50 per cent of iron ore export to Japan, IOO per cent iron ore export to Europe and about 50 per cent of the trade in other commodities as well as 100 per cent of coastal trade.

## Incidence of cataract in U.P.

K1SKU): (a) No specific survey has been conducted by the Government in regard to the incidence of cataract in Uttar Pradesh.

- (b) Yes.
- (c) The estimated expenditure on the scheme is about Rs. 16 lakhs out of which Rs. 7,86,000 have so far been sanctioned.

Uttar Pradesh has been divided into 8 Zones for the purpose of treatment of eye ailments. Every Zone has a base-hospital or a Head Quarters. The scheme of eye relief camps will be implemented through these 8 base hospitals.

The scheme will be executed in 4T Districts in plains, excluding the 7 hill Districts. One eye Relief Camp will be organised in every Block of these districts. A target of 100 cataract and other operations is fixed for every camp. In this way there is a target of 80,000" operations for the entire State. One operation is estimated to cost Rs. 20/-.
